8. CSIP & School Land Trust Plan (Goals and Expenditures)

- Goal 1-Reading. Measured by Dibels.
- Cherie-Parents question format and delivery of test. Mr. DeMill will let the district know.
- Gaetana-Worried about some kids being nervous with testing. Mr. DeMill-testing is a cold read, some kids can test with someone they know.
- Action Plan-Professional development, land trust funds help. Reading \$39,000 set aside. \$1,000 substitute pay. \$2,700 purchase technology. Swivel devices for teachers \$1,300. Total amount \$44,000.
- Goal 2-Math. 90% of students meet or exceed.
- Action Plan-\$18,000 for interventionist for math.
- **Goal 3-**Social/Emotional-Second Step program for kids struggling, this has already started.
- \$3,500 program curriculum
- \$1,000 multi-tiered system of support. Tara-ABS check in/check out. Cheri-Does Tara need more money? She is 25 hour employee, can get 3 more hours up to 28.

Projected funds \$66,500/Actual funds \$62,000. Projection could be different. \$4,527 carry over.
